Introduction

1. The Russia (Sanctions) (EU Exit) Regulations 2019 (the 'UK Regulations') were made under the Sanctions and Anti-Money Laundering Act 2018 and provide for is involved in activity whose object or effect is to destabilise Ukraine or undermine or threaten the territorial integrity, sovereignty or independence of Ukraine or to obtain a benefit from or support the Government of Russia.
2. On 21 July 2025 the Foreign, Commonwealth and Development Office specified 135 vessels under the UK Regulations.
